Current Awareness Alert①

- 特定のPractice area(法分野)またはトピックに関する新しいコンテンツを受信するように設定できます。

- 必要な数のアラートを設定し、トピックごとのアラート、または複数の主題をカバーするアラートを設定できます。
- まず、興味のあるPractice areaまたはトピックを選択し、Your Selection (選択済)ボックスに追加します。
- または、Practice areaをクリックすると詳細トピックが表示されるので、詳細トピックごとに選択することも可能です。
- アラートからコンテンツを削除するには、右側の Your Selection (選択済)ボックスから名前をクリックします。

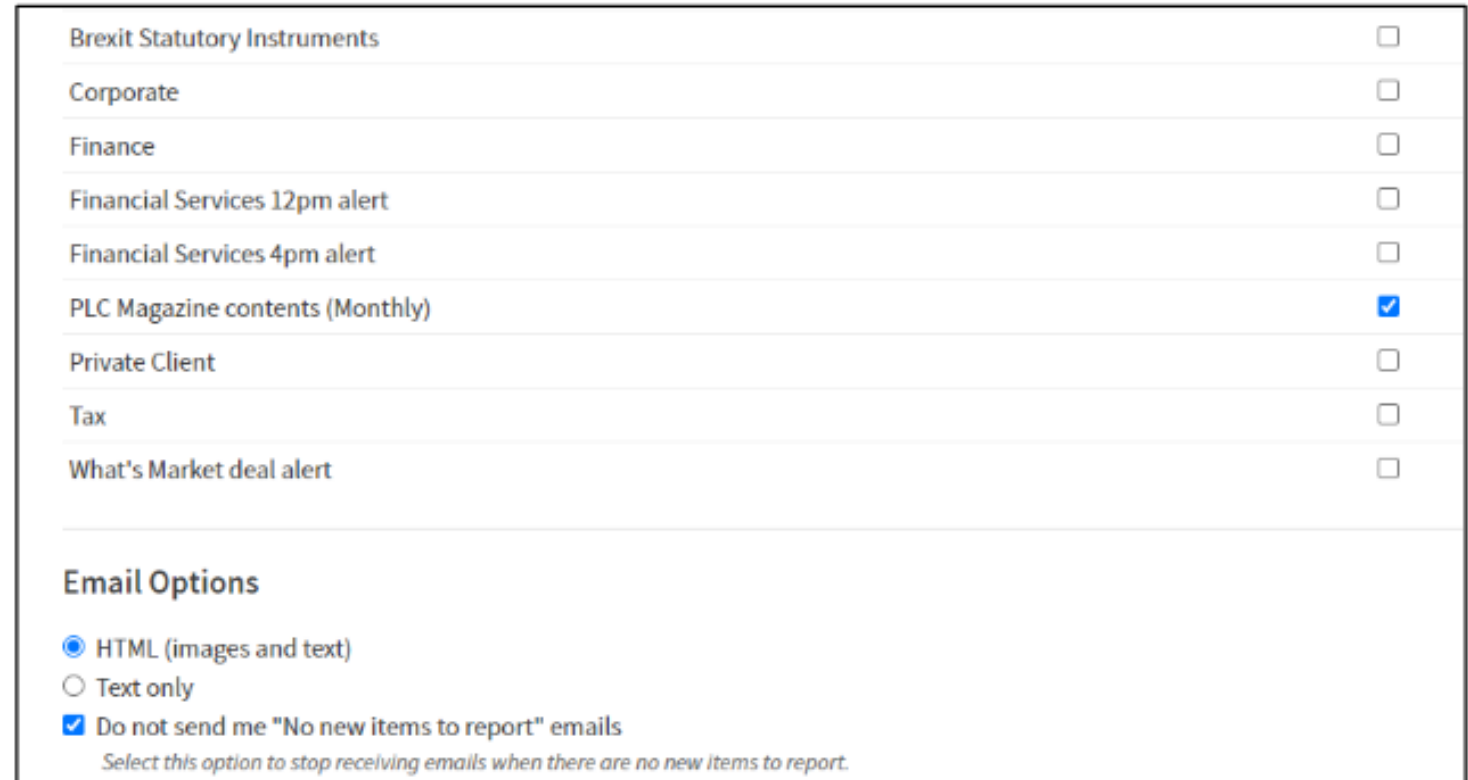
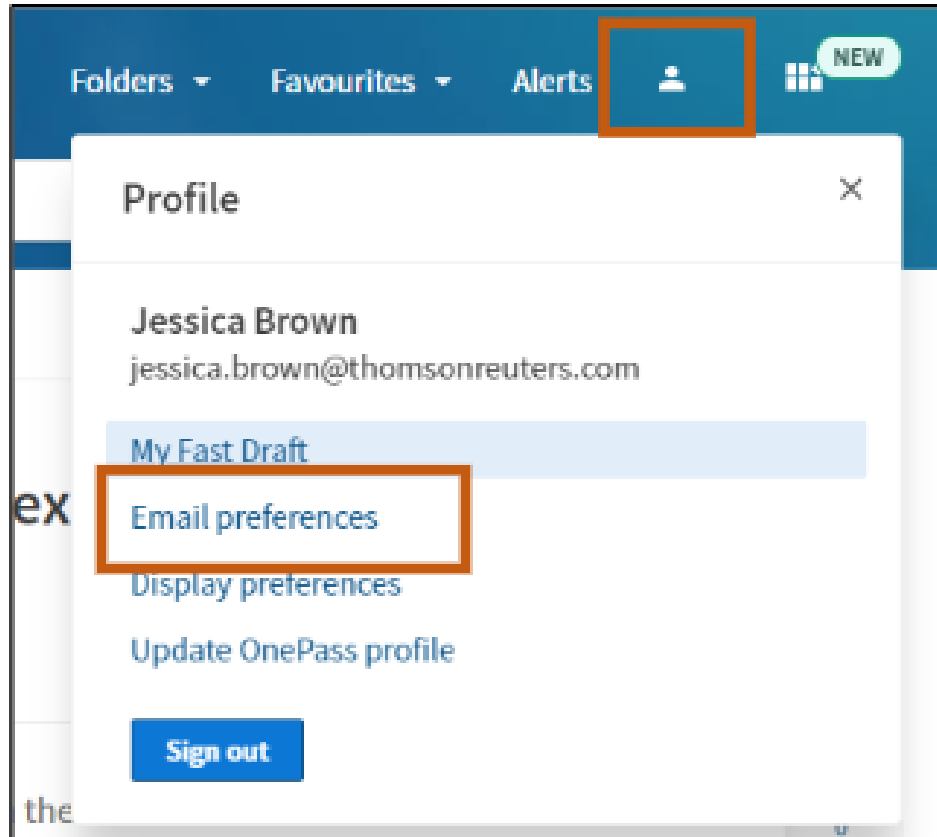
